(j) It may create and charter one or more Holding Commanderies for the purpose of retaining Sir Knights who were members of a Constituent Commandery which demised. Membership in such a Holding Commandery shall only be obtained by affiliation. A Holding Commandery may not create Sir Knights. The Grand Commander shall appoint the officers or a Holding Commandery, except that the offices of Recorder and Treasurer shall be held by the Grand Recorder and Grand Treasurer respectively, and the elected Grand Commandery officers shall be ex officio members of the Holding Commandery without payment of dues or assessments. All other members of the Holding Commandery shall be subject to the payment of all dues and assessments levied by the Grand Encampment, Grand Commandery and Commandery and shall be subject to discipline as otherwise provided by law. A Holding Commandery shall not be required to have a suitable Asylum, to meet quarterly, or to create new Sir Knights as normally required by this Constitution.

(i) The Commander of a Holding Commandery does not obtain the rank of Past Commander by virtue of such service.

Whereas changes in the Grand Encampment laws implemented have allowed for the lawful and formal creation of a Holding Commandery within the jurisdictions of Grand Encampment subordinate Grand Commanderies, and such has been the unofficial practice within this jurisdiction for an extended period of time regarding Coeur DeLeon Commandery, this legislature is *required* to be assimilated into the Constitution of the Grand Commandery of Minnesota for our jurisdiction to remain in accord with the Constitution, Statutes, Rules, and Law of the Grand Encampment of Knights Templar, U.S.A.
