

Public Installation of 2024–2025 Grand Officers

Rules of Order For Grand Council of Cryptic Masons of Minnesota

The business of all Masonic Grand Bodies will be conducted by "Masonic Tradition" and not by Robert's Rules of Order.

Must submit legislation so it is received at least 45 days prior to the Grand Session or if it is brought forward at the Grand Session it would need to pass by 100%.

The following Rules are for the discussion of any resolution or business before this Grand Assembly.

- 1. Resolutions will be presented by the Jurisprudence Committee.
- 2. The time allowed for each person to speak on a resolution will be 2 minutes.
- 3. A Companion may speak only once upon a resolution, either for or against.
- 4. Only two (2) Companion will be allowed to speak in support of a resolution and two (2) Companion will be allowed to speak against a resolution.
- 5. Any Companion wishing to speak will approach a microphone; state his name and the name and number of his Council. He will not start speaking until he has been recognized by the presiding officer.
- 6. After debate, if questions on a resolution or any other discussion remain, they shall be directed to the Chair of the Jurisprudence Committee.
- 7. There will be no personal attacks or vendettas during these business meetings.
- 8. There will be no discussion of politics or religion.

Report of the Most Illustrious Grand Master Roberto Sean Gardiner 2023 to 2024

Companions! Thank you for granting me the privilege of serving you while traveling this path. I have learned much about the craft. Delved into the meanings of our ritual. The history of our craft. The past leadership that developed and grew the Cryptic Rite. The influence Cryptic Masonry has had on our other Rites and Masonic bodies. The desire of other jurisdictions to adopt and learn from our Rite. All this knowledge shared with me in conversations with great companions, both within and without Minnesota. Thank you for that opportunity. I can only hope that in some small way I can share what I have learned with companions on their own journeys. Not only have I learned about the craft, but I have also been encouraged in my personal and professional development. I was pushed out of my comfort zone to achieve more light in all aspects of my life. To quote Gary Gygax "Of course as children, we all, in all cultures and societies, learn behavior from observation, imitation, and encouragement of various kinds." Thank you for being my example and encouragement.

As I come to the end of this leg of my Masonic journey, I have caught myself reflecting on all the work the Companions have undertaken while looking to the future. We have made improvements to how our Councils and the Grand Council operates. The slew of resolutions we have tackled year after year attests to our push to improve and grow. Although we have accomplished much for the betterment of the craft, as well as our own development, our work is not complete.

The strength of our Councils is built upon the foundation left by our predecessors and the conviction of our companions. An example from just this past year is our Grand Record and the Grand Secretary of the Grand Chapter of Minnesota. Most Illustrious Companion Marvin Schendel and Most Excellent Companion Joe Anderson have worked tirelessly to implement MMS this year. They have updated and corrected our membership rolls to provide accurate reporting which will be a tremendous benefit to our Councils and Chapters in the future. They exemplify visionary leadership. I charge you and each of you to take up the mantle of similar work and continue to improve how we operate and how we deliver the lessons of Cryptic Masonry. "Progress occurs when courageous, skillful leaders seize the opportunity to change things for the better.", Brother Harry S. Truman.

Brother Truman touched on a very important aspect, the need for skillful leaders. "The single biggest way to impact an organization is to focus on Leadership development. There is almost no limit to the potential of an organization that recruits good people, raises them up as

leaders and continually develops them", John Maxwell. "I start with the premise that the function of leadership is to produce more leaders, not more followers.", Ralph Nader. One of the many objectives of our craft is to recognize good men and develop them into great leaders. We need to identify and encourage those visionaries within our bodies that can lead us into the future. Visionaries that identify and implement the changes to better our craft. And while our constituent Councils should teach and develop leaders, our Grand Council should identify and inculcate the experienced visionary leaders from our Councils. I admonish our Companions to always remember the purpose of the Grand Council is to help administer the affairs of the craft and make the management of the Councils easier and more efficient. Do not suffer inaction or divisiveness for divisiveness's sake but seek those that are willing to administer to the needs of our Councils and Companions, those willing to labor in the heat of the day alongside us.

As I was a few years ago, I am still reminded of the motto of a friend. REPGC Patrick Sullivan taught me the value of "TEMPLE". To Teach and Educate our members, Master and Perform our ritual, Lead and Excel the York Rite into tomorrow.

There are many ways we can Teach and Educate. We should present education at our Councils. The most common request from our companions is for more light. Let us share of our knowledge and partake in the knowledge of others in presentations at our Councils. Let us teach and educate our Companions, so that they can help others build their Masonic edifice. Develop our future leaders. Be the example for the next wave of leaders to emulate. Inspire our companions to take on the mantle of leadership, work in the quarries to break off the corners of their rough stones and share with all companions what they have learned. We can also all share our knowledge when visiting our neighboring Lodges and presenting on the benefits of Cryptic Masonry.

Master and perform our ritual at the highest level. What better way of honoring the heritage left to us than by Mastering our ritual. Let us give our new companions the experience they crave and deserve by Performing it with a high level of proficiency. I understand the prolonged level of commitment this will take, but it begins with the first step, the desire to try. Masonry didn't become what it is in a single day, nor have any of us, it has been years of work. Let us take up this work and master our ritual. "No man can climb the ladder of success without first placing his foot on the bottom rung.", Brother J.C. Penney.

Report of the Deputy Grand Master

To: The Most Illustrious Grand Master, Grand Officers and Members of the Grand Council of Cryptic Masons of Minnesota.

RE: Deputy Grand Master's Report 2023-2024

As the Grand Deputy Illustrious Master (DIM) of the Grand Council of Cryptic Masons of Minnesota for 2023 – 2024, I have attended the Grand Officer's meetings, and many other Council and York Rite events. In addition, I served as the Area Representative for Zabud Council and have attended a number of their stated meetings. I also attended the annual York Rite Picnic in July, the General Grand Triennial in Branson MO in August, and the One Day to Masonry in January 2024. The following are my committee reports:

Finance Committee, as the chairman of the finance committee I see an urgent need to increase the budget to cover our increased costs. Last year's increase of \$5 covered the cost of moving to MMS, it did nothing to cover our normal and ongoing expenses. Inflation and the normal increase in the costs of goods and services are eating away our budget ability to support us. Our last budget increase for normal expenses was during the 2015 - 16 operational year. Therefore, it's time for an increase.

York Rite Grand Representative Program committee consists of MEC L. Greg Schultz and myself. Over the past several years MEC Greg and I have developed a Grand Representatives program that fulfills the needs of our York Rite bodies and should, with some minor adjustments, be suitable for any York Rite body. The York Rite Grand Representatives Program draft was completed and submitted to the General Grand Council for review and approval during the first quarter of 2023. As of January 2024, we have not received a verdict. It looks as though the Grand Representatives program may have fallen off General Grand's radar for the time being. We are however, looking forward to getting the Grand Representatives program fully implemented in the upcoming year.

The York Rite Emissary Program is up and running. We received our lapel pins and blank certificates in January 2024, and we began swearing in officers and emissaries in February. As of April 2024, we have 10 sworn emissaries in the program. We still have a number of volunteers that have not been sworn in and we are just beginning our training program. Currently there are 124 lodges in the state, but not all of them are active. The goal of the York Rite Emissary Program is to place an Emissary in each active lodge. The function of the Emissary is to keep their lodge informed of York Rite activities and events.

York Rite Education Committee has been actively reviewing and upgrading our educational materials. One of our ongoing goals has been to make quality educational materials easily available to all of our members. A goal for the upcoming year is to make additional educational materials available and downloadable from our websites. This will allow easy access to interesting and informative presentations. To add value for our members, every York Rite body should make education part of every meeting. We are always seeking volunteers to assist the Education Committee in building our library and presenting educational programs. Please consider volunteering.

I am looking forward to getting out and visiting our each of our Councils and many of our York Rite activities.

Report of the Trustees

Report of the Trustees 2023 – 2024

To: The Most Illustrious Grand Master, Officers, and Members of the Grand Council of Cryptic Masons of Minnesota.

It has been with great pleasure to serve our officers and members of the Grand Council of Cryptic Masons of Minnesota as your Trustees. 2023 – 2024 completes a 13 year service to the Grand Council of Cryptic Masons of Minnesota. We sincerely hope that your Grand Council Officers and membership of the respective Councils of Cryptic Masons in Minnesota have found value in the work your Trustees have done for you since we began in 2012. The Trustees communicated throughout the year serving the needs of Grand Offices, attending Grand Officers' meetings, Cryptic Rite Medical Research Fund, our Councils of Cryptic Masons in Minnesota, and Grand Council of Cryptic Masons finances and investments.

On the investment side of your Grand Council:

January 1, 2023 Investment Fund Value: \$64,093.98

June 30, 2023 Investment Fund Value: \$64,820.77

December 31, 2023 Investment Fund Value: \$69,324.38

March 31, 2024 Investment Fund Value: \$73,385.48

January 1, 2023 Life Membership Fund Value: \$55,582.30

June 30, 2023 Life Membership Fund Value: \$58,513.71

December 31, 2023 Life Membership Fund Value: \$62,579.12

March 31, 2024 Life Membership Fund Value: \$67.232.57

Four life memberships where added in 2023 thru March 2024 which raised our Life Membership portion of our total investment fund from 86.72% to 93.34%. In 2014 our Life Membership portion of our total Investment fund was 75.5%. Life membership increases do draw down the total investment reserves to 9.78% for our Grand Council. As of March 31, 2024, this amount is \$6,152.91. In April 2024 our Grand Council of Minnesota received a \$5,000.00 donation from the family of Stan Morrill, PMGIM. The family's check will be added to our investment fund to increase our investment reserve. Operating funds cannot be drawn from the Life Membership portion of the total investment fund.

Our rate of return for 2023 is 4.10%, up from 3.67% in 2022. 2023 resulted in \$2,565.74 allocation for our subordinate Councils for their Life Membership per capita.

Since 2014 \$24,855.20 was distributed with an average rate of return of 4.425% and average distribution of \$2,485.52 for the 10 year period. The financial stability and accountability are important to all organizations, including your Grand Council of Cryptic Masons of Minnesota.

From the Deputy Grand Master's Report

Finance Committee, as the chairman of the finance committee I see an urgent need to increase the budget to cover our increased costs. Last year's increase of \$5 covered the cost of moving to MMS, it did nothing to cover our normal and ongoing expenses. Inflation and the normal increase in the costs of goods and services are eating away our budget ability to support us. Our last budget increase for normal expenses was during the 2015 - 16 operational year. Therefore, it's time for an increase.

Grand Treasurer's Report

To: The Most Illustrious Grand Master, the Grand Officers and the members of the Grand Council of Cryptic Masons of Minnesota.

The 2024 – 2025 Budget shows very little change from the previous year and is a balanced budget. Your Grand Council is working to keep expenses down while providing all the necessary tools that are needed by both the Grand Council and the Constituent Councils of Minnesota. We are asking for an increase in the per capita this year to help with the regular expenses. Last year the per capita was increased to cover the added expense of MMS, which due to the efforts of the Council Recorders MMS has been implemented.

The last time the Grand Council raised the per capita for it's normal expenses was in 2016, the expenses have been held close, but it is time that we ask for help to meet the expenses, the Grand Officers are expected to travel and visit not only our Councils but also to go to the other Grand Councils in the North Central Region, along with attending the North Central Conference in Sioux Falls, SD. Those cost have increased also and an increase to those cost is reflected in the budget. They only cover a portion of the actual cost, but they do help. The Greeting Fee has not changed for many years, it is meant to be the same as the Per Capita. The new budget shows the increase.

Just a few comments on the 2023 – 2024 Budget

We were right on concerning the income.

We had several Grand Officers who elected not to have their expenses reimbursed. The MMS did not charge us for the Data Input, due to the efforts of our PMIGM Brian Dimatteo, he did most of the work for the original input. Thank you, Brian, the Grand Chapter and Council are indebted to you for all your work setting up the starting information. We will be seeing yearly charges for the service in the upcoming years and that is reflected in the new budget.

The Triennial Fund shows that we are over budget, we expense one third of the expense each year and put the funds into a separate fund, and when the Triennial is held, we pay out the expense in that year, which shows the entire cost.

CMMRF shows overbudget, we sent the Pass the Hat proceeds to CMMRF.

I want to thank the Grand Officers for their help in keeping the cost down, while they continue to work to make this Grand Council one of the Best.

They returned to "Brother John Smith, PGM" or "Companion John Smith, PMIGM". It wasn't until the mid 1900's that we elected to retain those honorifics as a status symbol. This would be a return to the practice of all Companions being equal. While officers are temporarily elevated by their peers, they return to their peers when completing their term of office. For the ritual states there is no higher honor than to be called Brother.

This would remove Honorifics from all but current officers. Past officers can still be addressed as

Companion John Smith, PMIGM. This does not remove the Companion's service as an officer, nor any of the rights from that service. Past Officers would still be able to wear their past regalia (aprons, jewels, and collars).



Most Illustrious Companion John Halberg Jones June 17, 1943 - June 5, 2023



Raised a Master Mason on November 17, 1964, John Hallberg Jones served as Illustrious Grand Master of the Grand Council of Cryptic Masons of Minnesota for a year and a half, from October 30, 1976 to April 21, 1978. This was due to a change in the Cryptic Council year.

During his term as Illustrious Grand Master of the Grand Council of Royal and Select Masters, he recommended its name change to the Grand Council of Cryptic Masons of Minnesota. This was because "it brings into the name the two specific words that describe us, namely, Cryptic Masons."

Member No. 1

- John brought the York Rite College to Minnesota, and founded Minnesota YRC No. 39. He was the last remaining "single digit" member of the College, joining on November 18, 1973, and its first Associate Regent...he received the Order of the Purple Cross on July 1, 1974. He was also the first Grand Governor in Minnesota, for the York Rite Sovereign College of North America.
- John founded Minnesota Council No. 111, Allied Masonic Degrees, and its affiliated Royal Ark Mariner Lodge. It is the oldest AMD Council in the state.

Masonic Rosicrucianism had been dormant in Minnesota since the second decade of the 20th Century, with the demise of Northwestern College. Together with David Sinclair Bouschor, he was instrumental in returning the Societas Rosicruciana In Civitatibus Foederatus (Masonic Rosicrucian Society) to Minnesota, in 1980. Transferring their memberships from Colorado, the SRICF was reactivated under a new name: North Star College.

Following the merger of St. John's Chapter No. 9 and Minnehaha Chapter No. 98, to become Minneapolis Chapter No. 9, Royal Arch Masons (now again called St. John's 9), Excellent Companion Jones served as its long-time Secretary.

John told me "My primary hobby is collecting memberships." In addition to Freemasonry, he belonged to many other organizations, chiefly in "Heritage Societies." It is known that he belonged to at least 79 of these groups, some familiar to the general public, some not. Examples include: National Society Sons and Daughters of the Pilgrims; National Society of the Sons of the American Revolution; First Families of Massachusetts; Flagon & Trencher: Descendants of Colonial Tavern Keepers; Registry of Famous and Infamous Relatives in American Families (nine out of nine categories); Son of a Witch; Descendants of Early Postmasters; Legion of Vikings and Valkyries; Order of Cloak and Dagger. There may be more! And, it wouldn't surprise me if John had a hand in the creation of some of the more uniquely named organizations.

In the community, he had managed state Senatorial campaigns, and served on what was then called the Parent Teacher Association. Among other things, he was also an Honorary Chief of the Minneapolis Fire Department. Masons are often called "traveling men," and John's favorite choice of travel throughout the country was leisurely: by train.

This barely scratches the surface about "Who was John Hallberg Jones?" John is survived by his wife Lorraine, and sons David and Daniel. His contributions to the York Rite in Minnesota are innumerable, as he was a 50+ year member of the York and Scottish Rites. For those who didn't meet or know the colorful character that was JHJ, I'm sorry you failed to have the opportunity to do so. He will be missed.
